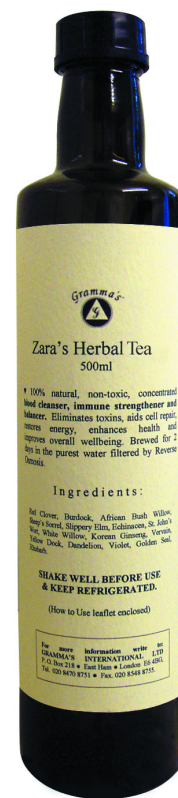

## 'MHRA' orders Gramma's® to STOP production & sales of Zara's Herbal Tea.™

Hello friends,

Well, so far this year we've had the credit crunch; global recession; election of President Barack Obama; highest unemployment rate; lowest Bank Interest rates; soaring food & fuel prices; exorbitant MP's expenses claims; 'swine flu'; plus planned compulsory vaccinations... **LIFE couldn't be better.** But over the past six months, we at Gramma's have been facing our biggest challenge to-date. Without prior warning or consultation, in June '09 we received an aggressive letter from **The Medicines & Healthcare products Regulatory Agency (MHRA)**, demanding that we immediately stop the production and sales of **Zara's Herbal Tea**, threatening court action. The reason being, they have decided that our tea is **A MEDICINE** and not a **herbal food supplement**. With **no right to appeal**, they have stated we must reformulate the tea, by removing all the ingredients they consider 'not for food usage'. Failing to comply, means that it cannot be sold without a full drugs licence, which could cost us upwards of £250,000. I am saddened to say, that this pressure from regulators is all part of a hidden agenda by the 'Powers That Be', to prevent the sale of large numbers of food supplements, herbal and other natural products. It's hard to find any justification other than the elimination of competition by destroying health businesses to secure maximum profits for the pharmaceutical industry. This situation is extremely serious therefore, we urgently need your support to challenge the MHRA's decision, plus UK & European laws affecting both our health and the health food industry. ## Rebalancing the Scales-of-Justice:

As you know, the impartial fairness of the **LAW** is often symbolized by a '**balanced scale**', whilst the **legal system** was created to serve and protect its citizens and the environment around them. However, in recent decades when it comes to managing our health by natural means, the scales have become increasingly unbalanced in favour of synthetic drugs, additives, genetically modified (GM) and other unnatural foods; widely proven to endanger rather than safeguard our health. My recent encounter with the Advertising Standards Authority (associates of the above mentioned MHRA), banning our advert promoting Zara's Herbal Tea and now forcing us to stop production, is a clear example of this '**artificial v natural**' issue.

This threatens not only our own Caribbean tradition, and those who have benefited from it, but also other long-standing traditions such as Ayurveda and Chinese Medicine, all of which have evolved over many thousands of years. If left unchallenged, within a very short time, 'valuable' ancient knowledge and expertise will be lost **forever**.

These regulations will eventually eliminate and drastically reduce the effectiveness of many essential 'herbs, vitamins & supplements' commonly used today. **Organic-foods will gradually be eradicated and in its place genetically modified (GM), irradiated foods and other unnatural foods** will be promoted as a cheaper, healthier option. This will ultimately destroy the environment and create an increasingly 'sick society' dependant solely on artificial foods and prescription medication. The impact would be catastrophic and irreversible. To make matters worse, this information is being deliberately hidden from the general public by Government Ministers, Medical Establishments, the World Health Organization (WHO) and a biased Media, to

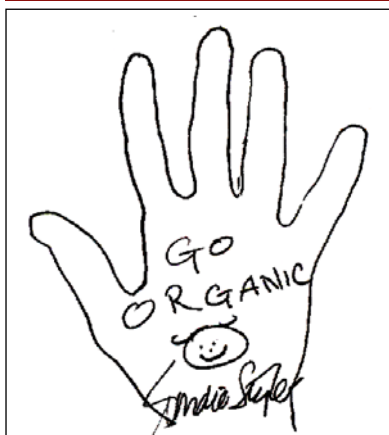

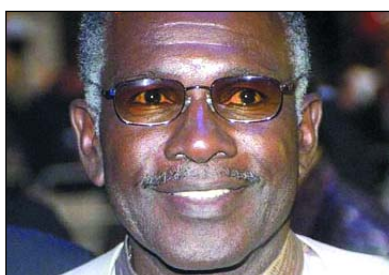

# GRAMMA'S® Founder Dounne Alexander, defends Zara's Herbal Tea Advert against ASA ban.

On 15th March 2009, we were truly surprised and extremely disappointed with the response received from the Advertising Standards Authority (ASA), to our first advert promoting **Zara's Herbal Tea**, which they'd found to be **'misleading, irresponsible and likely to exploit the vulnerable'**. Further claiming that we did not supply evidence to prove each of the conditions mentioned. This we found quite disturbing, as we had submitted the following information -

- Our 14 years of extensive 'independent research' on Zara's Herbal Tea (originally advised by the Department of Health, as an acceptable form of research evidence).
- 14 pages of 'authentic customer testimonies' (on both humans & animals), to prove the tea's outstanding effectiveness on all conditions mentioned, including Zara's Vet's detailed report, confirming her cancer diagnosis and successful recovery after taking the herbal-tea. **No psychological 'placebo' tests were necessary as it proved equally effective on our customers animals.**
- Our **DISCLAIMER** confirming that the tea is a **'herbal food-supplement'** to be used as part of a balanced nutritious diet to help improve, manage and maintain optimum health and not intended to **treat, prevent, heal** or **cure** any of the conditions mentioned.
- The list of ingredients alongside factual documented information by qualified botanists and herbalists on the known benefits of each herb.
- Centuries of ancestral heritage, 'self-healing' knowledge and traditional practices... based on the ancient principle that **natural foods are meant to 'feed & heal'**; provided in abundance in nature by a **God-of-Love** to prevent sickness and maintain good health.
- 20 years extensive 'scientific research' conducted by British & American scientists on one of the tea's key ingredient (The African Bush Willow- combretastatin), confirming it to be 85% effective on cancer tumours - and hailed as the biggest cancer breakthrough... prompting them to develop a new 'synthetic cancer-drug' now being trialed in hospitals throughout America and the UK.

It seems strange that such an exciting, innovative and unique (British) product as **Zara's Herbal Tea**, (which to my knowledge is the only commercial product in the world to contain the 'African Bush Willow'); that could potentially **restore the nation's health;- eradicate health discrimination** (by providing consumer choice & affordable healthcare);- **encourage, educate & empower everyone** to take responsible control of their own health; plus **save the NHS billions...** could be deemed as **misleading, irresponsible or exploitative**. All of this was sufficient evidence for the **Public Health Minister** to approve Zara's Herbal Tea for use in hospitals and hospices, but somehow was inadequate for the ASA.

The ASA states that according to the law **'a product cannot be both a food and a medicine!'** Even if there is evidence proving that the food-product can combat or is beneficial for a disease or condition, **you are prohibited 'by law' from revealing these truths** and it is in fact a criminal offence to do so. This clearly makes **ILLEGAL**, the statements made by the two most renowned medical names in history... **Hippocrates** (the ancient father of medicine) **"Let thy Food be thy Medicine and thy Medicine be thy Food"** - based on the 'Laws of Nature & Nutrition', used successfully to this day by doctors and herbalists - Plus **Paracelsus** (the ancient father of Pharmacology) **"All that man needs for health and healing has been provided by God in nature, the challenge of science is to find it."** Something is **'morally, consciously and spiritually wrong'** with an Establishment that prevents the absolute TRUTH from being told, especially if the truth could potentially prevent poor health, unnecessary suffering or premature death. For instance, **prescription drugs** are scientifically proven to be extremely addictive, highly toxic (with horrendous side-effects), and also the world's third biggest killer. As confirmed this year by **Deepak Chopra** (renown physician & Ayurvedic practitioner) - **"there are more people today addicted to prescription-drugs than street-drugs."** Whereas, **natural herbal supplements & remedies** are non-toxic, non-addictive with no known reported deaths to-date. Therefore, it leaves us questioning the legitimacy of the modern-day **British food & medicinal laws**, which appear to have little regard or respect for natural healthcare, nutrition or informed consumer choice; but weighs heavily in favour of 'synthetic medication & artificial foods'... that offers a false sense of hope. It's apparent that 'profits over-ride our health & safety', hence it is far more beneficial to keep the nation sick rather than healthy. It is well known by most in the health and herbal-food arena that these **BIG industries** have infiltrated the **Powers That Be** (including the media networks) and are extremely influential both in the UK and overseas. Hence, the ASA is only a small part of a huge jigsaw that is cleverly taking away your **human-rights & consumer-choice**.

## Medicines and Healthcare products Regulatory Agency (MHRA)

Within 2 weeks of posting this defense on our website, we received an aggressive letter from the above agency (associates of the ASA), ordering us to immediately stop the production and sales of Zara's Herbal Tea; threatening court action. It is for these reasons that I feel morally obligated to challenge the ASA & MHRA's decision, plus the legitimacy of the current laws. To destroy; give way to distrust, ruin our reputation, bully or to deceive the public under the pretense of consumer protection... is simply unacceptable. Therefore through our **JOINING HANDS IN HEALTH** campaign, it is my hope that **'People Power' will prevail in persuading the Government to review the present laws and establish a new legal framework to protect Natural / Herbal Foods, Herbal Supplements and health businesses.**
