- Your Majesty, this OPEN LETTER has been entrusted to various 'reliable individuals' (worldwide) for safe keeping, plus circulated to the general public to ensure that they are made aware of the impending threats to their lives. This letter has also been sent to Prince Charles, Prince William, the Prime Minister, Deputy Prime Minister, Cabinet Ministers, Opposition Leaders; all members of both Houses-of-Parliament; Mayor of London and UK MEPs.

Your Majesty,

My name is **Dounne Alexander, MBE. FRSA**. I am the founder of **GRAMMA'S®** (a specialist manufacturer of Traditional Herbal Foods). I am also the founder of **Joining Hands In Health®** (an independent, not-for-profit, voluntary, awareness campaign); and the inspiration behind nationwide petition **THE NATION SPEAKS – “NO! Not In My Name”** (to safeguard our democratic freedom, human rights, health choice, natural foods, cultural traditions and the environment).

Please find (overleaf), a personal plea which is also submitted on behalf of the nation, alongside my case study and research concerning the new EU Food Supplements Directive (EUFSD); the Cancer Act 1939 and forthcoming Codex Alimentarius (i.e. *the food code*) Standards & Guidelines.

## ‘A PERSONAL PLEA’

I appeal to ‘**Your Majesty**’ to intercede (on the nation’s behalf) and request that the UK Government **OPT OUT** of the **EU Food Supplements Directive ‘2002/46/EC’** (incorporating the **Nutrition & Health Claims Regulations ; Human Medicinal Products Directive; Traditional Herbal Medicinal Products Directive**, plus others)... and in its place, establish an independent legal framework based on **NATURAL LAW & COMMON LAW** that will;

- (1). **SAFEGUARD** *natural foods, vitamins, minerals, herbs, supplements, traditional medicines & practices, indigenous remedies; and the natural health industry.*
- (2). **SECURE** *the democratic freedom (of choice in nutrition and health), human & religious rights of UK citizens and future generations.*
- (3). **PROTECT** *animal health & welfare.*
- (4). **PRESERVE** *our natural environment.*

Although Your Majesty does not normally intercede in Legislative affairs, I believe where any Government puts the lives, health and welfare of your people at risk of imminent danger, it is then the duty of the nation’s highest power (**the Crown**) to intercede. If Your Majesty does not do so at this late stage, I fear that **your kingdom and citizens, whom you promised to defend and protect**, could witness one of the greatest infringements and some of the most restrictive regulatory schemes ever experienced on our *democratic freedoms, human rights, personal choice and natural healthcare*. This could result in an unprecedented threat to our health, lives & livelihoods, as we know them today. We may then be left with a system that replaces ‘natural health & alternative therapies/practices’, thus paving the way to a pharmaceutical drug dependent culture. Unless the EU Food Supplements Directives are successfully opposed or redressed we could see:

- Thousands of beneficial natural foods, herbs, products & supplements, many of which have been ‘proven safe & effective’ for centuries and still commonly used today (to combat serious illness or to maintain overall health)... will effectively be **banned**.

- Many Traditional Medicines from non-European countries (including their products & practices) may also be **banned**, thus preventing their continued access, use, success and effectiveness in the UK and EU markets.
- Massive restrictions on maximum permitted levels on vitamins, minerals and herbs – (reducing their effectiveness).
- Severely strict censorship on what can be said about the beneficial properties of any natural product, supplement or food.
- Imposition of restrictive pharmaceutical-type standards, making it difficult for many companies producing natural products to comply.

Although the Government and Opposition Leaders have openly placed the nation's **HEALTH** as a top priority; also pledging support for small businesses and encouraging innovative enterprise... behind closed doors, they are introducing foreign and draconian laws which threaten the survival of both. In July 2010, the Health Food Manufacturers Associations (HFMA) estimated that around 700 independent health shops and 4,000 jobs will be lost. This does not take into account the many thousands of individual therapists, practitioners, producers and suppliers, who will be equally affected.

Lack of transparency, accountability and secrecy has given rise to distrust and questions the hidden agendas behind the legislations. However, with countless campaigns and petitions falling on deaf-ears due to vested interests, and others seeking Statutory Regulations... **it is imperative that the Government now uphold the liberties of all UK citizens and govern them according to their common laws, customs, cultural traditions, democratic / human / religious rights & freedoms.**

As our reigning Monarch, I call upon Your Majesty to make good on your pledge to defend and protect our heritage.

My personal case study provides clear evidence of what is happening now and the shape of things to come, showing the systemic abuse-of-power imposed by these legislations, which are fiercely enforced by UK Regulators. The United Kingdom is already in the grips of anti-social behaviour and chronic sickness (eg. cancer, diabetes, obesity), which will continue to escalate if 'natural foods, supplements, traditional remedies & practices' are not widely available to help provide continued balance and nutritional stability. I believe that **nature** keeps us grounded, making it essential for us to remain connected. The UK has also lost its way and needs to restore a sense of old fashioned values (i.e. *community spirit, pride, respect and belonging*), which can only be achieved through the maintenance of traditions. As per Your Majesty's Coronation Oath (overleaf), I pray you will intercede and save your people from a life of perpetual ill-health, extreme censorship and enslavement.

*The Archbishop:* “Will you **solemnly promise and swear** to govern the peoples of the United Kingdom of Great Britain and Northern Ireland... according to their laws and customs”

*The Queen:* “I **solemnly promise** to do so”.

I truly believe that this **solemn promise** is binding throughout Your Majesty’s reign.

In recognition of the **British National Anthem**, (written in 1740 and sung throughout all British Territories and national games, to this day). The last verse clearly confirms our praise, prayers, trust and hope - placed in Your Majesty.

*“ Long may she reign!

## PERSONAL BACKGROUND

### **DOUNNE ALEXANDER, MBE FRSA.**

Wife, mother, spiritual herbalist, author, motivational speaker, mentor, health campaigner and award winning business pioneer. Also the founder of **GRAMMA'S® Herbal Foods;- Joining Hands In Health®** and **THE NATION SPEAKS – “NO! Not In My Name”**.

I am a British citizen with dual Caribbean nationality. Born in the Caribbean Island of Trinidad in 1949 – which was part of the **British Empire** ; governed under British rule for 160 years (1802), until it gained independence as a Republic in 1962. However, before Britain... Spain ruled Trinidad from 1498 and gave away lands 'free' to encourage European settlers (*eg; German, Spanish, French, Italian, Dutch, Portuguese, Scottish & Irish*); whose ancestors still inhabit the island as Trinidad-nationals. Since its independence in 1962, **Trinidad retained the British Privy Council as its final Court of Appeal; plus is also a member of the 54 Commonwealth Nations to which Your Majesty is the ‘Symbolic Head’**. Therefore, being European ruled for 464 years (including the slave-trade years), means that as far as the new European Union is concerned, our cultural traditions are intrinsically linked and should be collectively honoured, valued, acknowledged and respected.

Additionally, like many others, my proud - loyal ancestors dutifully fought and sacrificed their lives in both world wars to secure Britain's *sovereignty, independence, democracy & freedom*. My late grandfather was honoured on Your Majesty's Coronation year (1953) with the **MBE Medal**. Their **Birth Right** afforded me the privilege and freedom to immigrate to Britain in 1964, where I have settled, worked, married and raised wonderful British children.

However, sadly after 46 enjoyable years in this country - my freedoms, cultural traditions, rights and livelihood are now seriously threatened by the imposition of the new EU Legislations. The imposed restrictions have created both a moral & spiritual dilemma, forcing me (for the first time) to consider leaving Britain and my family... in order to safely operate my business in another country, where democratic freedoms and 'basic' human rights still exist and are respected. The results of which would not only mean the painful break-up of my family and expensive relocation costs, but also the loss of one of Britain's potentially most innovative, ethical businesses, alongside extraordinary 'herbal products' which could restore the nation's poor health. Additionally, my customers (95% Caucasian residing throughout the UK) will be forced to pay more to obtain these British products. I am just one of over 1000 small health businesses under threat. If left unchallenged, valuable natural products, ancient knowledge and expertise could be lost forever and with it, the nation's health.

## PERSONAL ACHIEVEMENTS:

The British Food Industry in 2007.

**In 1987:** I created a media frenzy and hailed a national inspiration, when (as a single-parent, without any formal business experience, qualifications, training or finance) from my tiny Council flat kitchen ... I set up (**GRAMMA'S**) and within 3 months, launched my sensational *Gramma's Herbal Pepper Sauces* into Britain's most prestigious department stores Harrods and Fortnum & Mason. A year later, they were proudly on the shelves of Harvey Nichols, Selfridges; Bentalls, Rackhams, Howells and Kendale Milne. After a two year battle with British Banks, I successfully negotiated them into the top 7 supermarket chains nationwide (Tesco, Safeway 'now called Morrisons', Asda, Waitrose, Sainsbury, WM.Low, Co-op); health stores, plus stores in Ireland. A feat never before achieved single-handedly by any small British business-owner with the largest national distribution (listings in over 700 stores). Thereby, effectively opening the mainstream doors for small businesses in the UK; inspiring others to follow suit. [www.grammasintl.com](http://www.grammasintl.com)

- **1990:** With my sauces safely secured on the shelves, I then learnt that the British Medical Establishment believed that **hot-peppers** were dangerous to health and therefore discouraged its use in food. So I initiated the first national Health Education & Awareness Campaign on the nutritional health benefits of **hot-peppers** and produced the first detailed literature on its 'folklore' medicinal history. With the backing of renowned British medical professor – Irwin Ziment (a leading specialist in respiratory disorders & head of the American UCLA School of Medicine), who verified that the whole western Chemical Industry of 'cough-medicines & expectorant-drugs' was established because of the ancient folklore knowledge of the **hot pepper**. This campaign led to doctors worldwide requesting the leaflet and within 2 years, my name was recorded in the 'Hall-of-Fame' of the **American Chili Institute**, for bringing about international recognition of the health enhancing benefits of 'Hot Peppers & Spicy Foods', making it the essential ingredients enjoyed in most meals today. Thereby, transforming the traditionally 'bland British palates into fiery food-lovers', plus gained the respect of the Medical Establishment, Doctors and Gourmet Connoisseurs alike. My Herbal Pepper Sauces even became a favourite of Princess Anne.
- **1992:** Despite all of my achievements, behind the scenes I faced enormous barriers blocking my path to success. So I wrote and self-published my first book ***The Black Cinderella*** ... giving a first-hand insight into British Banks insensitivity towards women; start-ups & minority businesses; institutionalized racism & discrimination; lack of financial support & access; in-effective training; lack of legal redress; corrupt insider

dealings, plus *how & why* the system was deliberately designed to guarantee failure instead of success. I was immediately headhunted by the Shadow (Labour) Government as their **business advisor** at cabinet level. My recommendations brought about the appointment of a '**Banking Ombudsman**' for small businesses (providing legal redress for the first time); **increased the Loan Guarantee Scheme from £100,000 to £250,000**; development of '**women**' **focused Enterprise Training Agencies**, plus other major policy changes still benefiting businesses today. I was frequently called to lecture in universities, schools & colleges throughout the country.

- **2000 millennium:** Honoured as a **true pioneer** and voted amongst the **100 greatest & most influential black people in British history** (contribution filmed by the BBC and archived in the **British National Library**).
- **2000: Face of the Millennium:** chosen by Oil of Olay for their international advertising campaign as one of the over 50's face for the millennium. This kick started a part-time career as a classic model.
- **2001:** Launched my second book **A Mission of LOVE** in the House-of-Lords. Written in 1995, spiritually based and proving ahead of its time; it provides an in-depth insight into the dangers of scientific interference, with clear warnings of what is to come and how to safeguard our health and the natural environment. \*Adopted by Coventry University as a course study text for *leadership, entrepreneurship, personal / spiritual development, natural health and social responsibility*. Plus used by individuals for self-development; and by entrepreneurs as a true insight into 'what it really takes' to become your own boss (especially minorities, females & single-parents).
- Launched the **Joining Hands In Health Campaign** in City Hall (the Mayor of London's office)... to encourage everyone back to a more natural way of life; plus take personal responsibility and control of their own health.

This case study will show clearly how the TRUTH is deliberately being suppressed, whilst FEAR promoting sickness is instilled to profit from human and animal suffering. ## **WAKE UP CALL!**

### ***The Story behind ZARA’S HERBAL TEA:***

In 1994, my eldest daughter’s dog ‘ZARA’ was diagnosed with terminal (mammary) cancer;- given only 2 weeks to live as the cancer was too advanced; too aggressive and inoperable. The Vet sadly confirmed there was “*no hope of survival*”, as no medication or treatment could possibly save her and advised euthanasia as our only option. My daughter then asked a thought provoking question;-

Determined to get the tea scientifically researched, I then sought guidance from several doctors and medical professionals, who believed it showed potential and therefore warranted further investigation. I was warned that the cost of medical trials would be beyond my means but as a trained Laboratory Technician, I could set up my own independent 'in-house' research to determine its full effectiveness, in order to justify scientific research. Understanding what this would entail, I decided to put my promising business on hold and set about the research using myself, family, customers and their pets.

Whilst conducting the research, I continued the search for scientific trials via the Department of Health & local Primary Care Trust, but later realized that I was sent on a 14 year wild goose chase (see page 25). Nevertheless, the independent research was successful, as the tea proved to be extremely effective on a wide range of conditions; non-toxic and beneficial for maintaining overall 'whole body' health. I have since collated hundreds of proven testimonies, plus the botanical history verifying the traditional usage, non-toxicity and effectiveness of each herb. These were sufficient evidence for the Public Health Minister (Dawn Primarolo) to approve the tea (in 2008) for use in hospitals and hospices.

- Incidentally, Zara lived for additional 5 years; maintaining a good quality of life; no secondary cancers ever developed and she finally passed away peacefully and pain-free from old age at 15. This in itself was remarkable, as the average life span for Labradors was only 12 years. The survival period for cancer sufferers is 5 years. Understanding that one year in a dog's life is the equivalent of 7 years in human life. I uncovered private evidence that this herb had undergone over 20 years extensive collaborative research between British & American scientists... who confirmed it as one of the most powerful anti-cancer herbs – (85% effective on tumours) – and hailed as a great cancer breakthrough. The various universities, hospitals and cancer charities

involved in the research includes:- London's Royal Free Hospital; University College Medical School;- the Gray Laboratory Cancer Research Trust and Cancer Research UK (Dr. Barbara Pedley & Dr. Lesley Walker); Mount Vernon Hospital in Middlesex (Professor Gordon Rustin);- University of Florida, Ireland Cancer Center in Cleveland, Ohio; Pennsylvania Cancer Center; Arizona State University. A **synthetic-drug derivative** has since been developed and approved by the American FDA;- and is currently being trialled in selected hospitals throughout the UK (under the approval of the then Prime Minister - Gordon Brown and Cancer Research UK).

However, this drug only targets 'specific types of cancer' and (like others), is likely to be toxic, with many unknown side-effects; plus not 100% effective. **Therefore, it will not cure cancer.** Whereas, **Zara's Herbal Tea** has been shown to be beneficial not only for **cancer**, but also a wide range of conditions including *heart disease, strokes, seizures, diabetes, high blood pressure, respiratory disorders (flu, colds, bronchitis, asthma, emphysema), viral infections, incontinence, indigestion, food poisoning, constipation, irregular & painful periods, menopause, fluid retention, pain, tiredness, nervous anxiety, skin disorders, allergies, nausea... increases energy, speeds up recovery, calms aggression, aids restful sleep and lots more.* It proved so **non toxic** that even pregnant mums and babies had no apparent negative side-effects, with the added bonus of increasing their breast milk (even when it dried up). **In fact, it often healed where medication failed**

After gaining approval from the Public Health Minister and with over 14 years research evidence, in January 2009, I placed a small (¼ page) advert in a vegetarian magazine. One month later, I received a letter from the Advertising Standards Authority (ASA), who had received two complaints stating - the advert was '**misleading; irresponsible and likely to exploit the vulnerable**'. I provided the ASA with the Health Minister's approval; documented research evidence, testimonials, plus discussed the case over 3 months. Unfortunately, they still upheld their decision and promptly posted it on their website. Naturally, to defend my

(22 year old) business, products and reputation, I placed the true version of events on GRAMMA'S website. Within two weeks, I received an aggressive letter from the Medicines & Healthcare Products Regulatory Agency (MHRA), giving me 14 days to stop the production, marketing and sales of Zara's Herbal Tea. The reason being, they were advised by the ASA to review the tea and decided to classify it as a **MEDICINE...** overturning my classification as a **HERBAL FOOD SUPPLEMENT**. I was given **no right to appeal, consultation and threatened with court action**. Plus, was warned that the MHRA (who has more powers than the police), could confiscate the product, ingredients and close my business down, if I did not comply.

As a result, Zara's Herbal Tea cannot be sold without a **Medical license**, (costing upwards of **£250,000** – issued exclusively by the MHRA).

In order to obtain 'a license', I would first need the following:

- **Scientific verification**,  
(costing **over £5 million**, which would take several years, *even though the tea has already undergone 14 years independent research and proved to be non-toxic, safe, effective, without apparent side-effects on humans or animals*);
- **Toxicology testing**,  
(costing **over £100,000**, although the tea has proved to be non-toxic. *\*Toxicology testing is essential for 'synthetic medication' as they are made from artificial (often poisonous) substances and not from natural sources.*

However, because of recognized corruption within the medical establishment, pharmaceutical industry and MHRA (eg. scientists allegedly paid to falsify results), this threatens the likelihood of a positive outcome. Additionally, the **application process** is designed deliberately technical and complex; with excessive data requirements (weighed heavily on scientific authority). This is impacted by the fact that scientists are not trained in nutrition, traditional practices or indigenous remedies. As the relationship is incompatible, this makes it virtually impossible for (small & medium size) manufacturers to comply. Nevertheless, as a small manufacturer, even if it was remotely possible to raise such huge finance, the whole process would take many years to fully comply, in order to bring the product back onto the market. Nevertheless, even after satisfying all of the above, it still does not guarantee license approval.

Alternatively, to be accepted as a **Herbal Food Supplement**, the MHRA insisted on the removal of 4 herbs 'they' considered to be medicinal, plus the reformulation of the tea to their specifications. Additionally, they also insisted that they must be informed of and also approve any other future ingredients, I wish to include in the tea. This in fact, means the 'complete control' of all future products I intend to market. However, on speaking further with the

MHRA, it became apparent that their concerns had nothing to do with public health or safety, but solely centered on purchasing ‘**a medical license**’ and the removal of a **specific herb** (*The African Bush Willow*), which could pose a serious competitive threat to the pharmaceutical industry. It was also noted that at a fraction of the cost of pharmaceutical cancer-drugs (£25,000 to £35,000 per person annually), Zara’s Herbal Tea would be affordable to the public (at £500 per person annually) thereby, saving the NHS billions.

However, I later learned that even if I did comply with their wishes, the MHRA had no intention of reclassifying the tea as a Herbal Food Supplement. Therefore, citing *abuse-of-power, conflict-of-interest, bullying and unfair competition*, I refused to remove the 4 ingredients as their demands did not take into account, consider or respect my spiritual, cultural & traditional beliefs; plus would reduce the effectiveness of the product and business potential. They then called a meeting in December 2009, involving the local Trading Standards & Environmental Health Departments, after secretly holding a private meeting without my knowledge. With their consent, I recorded the (2 ½ hour) meeting in which they proved their lack of knowledge & expertise, in-experience and incompetence. Furthermore, they used ‘**blackmail**’ to force me to divulge my ‘**trade secrets**’ (*i.e. the detailed list of ingredients and individual weights* of both Zara’s Herbal Tea and Willow Herbal Tea), strongly indicating that with this information, they could reconsider classifying both teas as ‘Herbal Food Supplements within 2 weeks’. After they signed a ‘non-disclosure agreement’, it truly pained me to provide this sacred information (as insisted by my legal advisors). The MHRA reneged on their proposal and subsequently past my case on to the Novel Foods department. In May 2010, I was forced to remove both herbal teas off the market

I truly believe **Zara’s Herbal Tea** is being targeted not only because it healed Zara and others from cancer, plus proved beneficial for overall health... but to my knowledge, both Herbal Teas are the only commercial products in the western world containing the natural ‘**African Bush Willow**’. It became quite apparent that the MHRA’s goal was simply to extort the ‘recipe trade secrets’; remove the **African Bush Willow herb**, plus take Zara’s Herbal Tea off the market as quickly as possible, as it could pose a huge financial threat to their funders (the pharmaceutical industry).

Additionally, the Royal Marsden (Britain’s most respected cancer hospital) approached me to trial the tea on cancer patients... but cannot proceed until this issue is resolved. The MHRA’s decision also affects three other products in the pipeline, containing some of the herbs they have banned for food use.

In a nutshell, this amounts to...

A ‘**natural herb in a natural product**’ (proven safe, non toxic & effective) has been **BANNED**. Whilst the ‘**synthetic toxic derivative**’ (not yet proven, safe or effective) has been **APPROVED** and currently being tested on cancer sufferers throughout the UK.

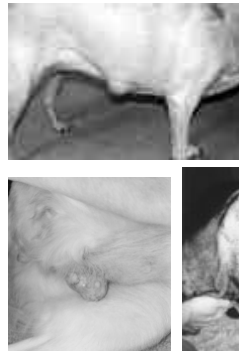
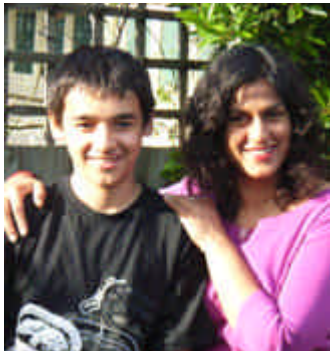
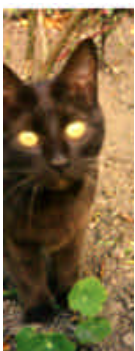
To date (December 2010), the MHRA have failed to produce any evidence of their determination, classifying Zara's Herbal Tea as a **'medicine'**. I provided the full medicinal details of all 15 ingredients in both herbal teas and questioned - **'how were they able to isolate 4 ingredients as being medicinal,'** when all the ingredients have medicinal properties. Below is a copy of my letter to them in June 2009.

*"We also feel very strongly that the MHRA should not use **'medicinal law'** to prevent **traditional teas** from being marketed. In contrast with **'conventional teas'**, in which the flowers and leaves are used, **'traditional herbal teas'** typically include other plant parts, including bark and roots. The same can be said of culinary herbs, where bark (e.g. cinnamon), roots (e.g. turmeric), pericarp (e.g. star anise), seed (e.g. nutmeg) and other plant parts are often used. A large number of these have medicinal properties, but the dose at which they are delivered means that their effects are not significantly pharmacological.*

*We propose that this is also the case with the herbs in the Zara's Herbal products. In fact, based on the MHRA's decision to classify Zara's Herbal Tea as a medicinal product, we request that the MHRA provides us with evidence of significant pharmacological, immunological or metabolic effects (that are substantially greater than those which might occur following the consumption of particular foods and food supplements that are presently sold under food law) for the herbs as used and delivered in our products. Should the MHRA still uphold that the product is medicinal, we intend to challenge this decision."*

I examined 'Zara,' a 10<sup>1</sup>/<sub>2</sub> year old Labrador Retriever on 2nd February 1994. At this time, she had a growth in her mouth which was subsequently removed. 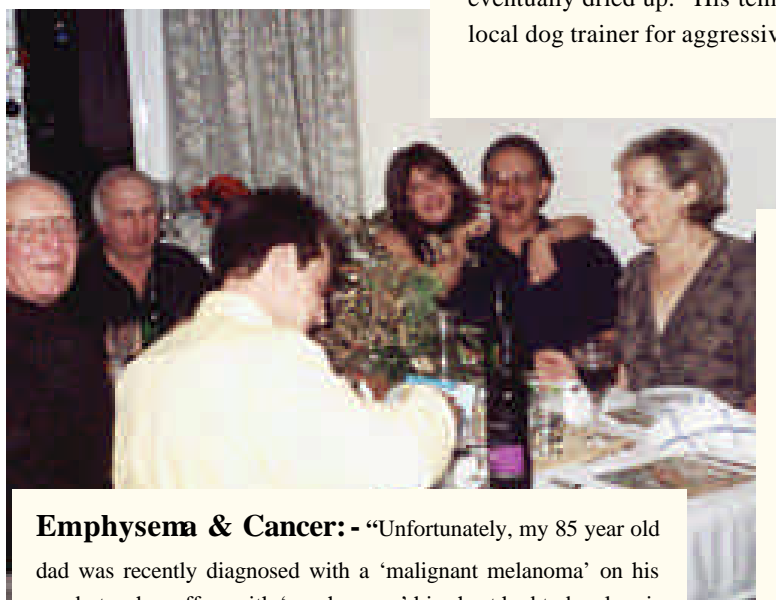

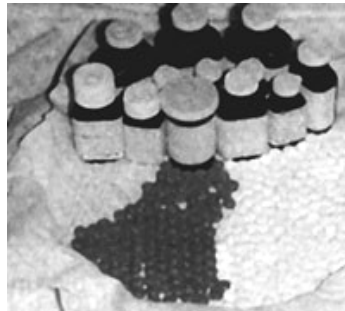

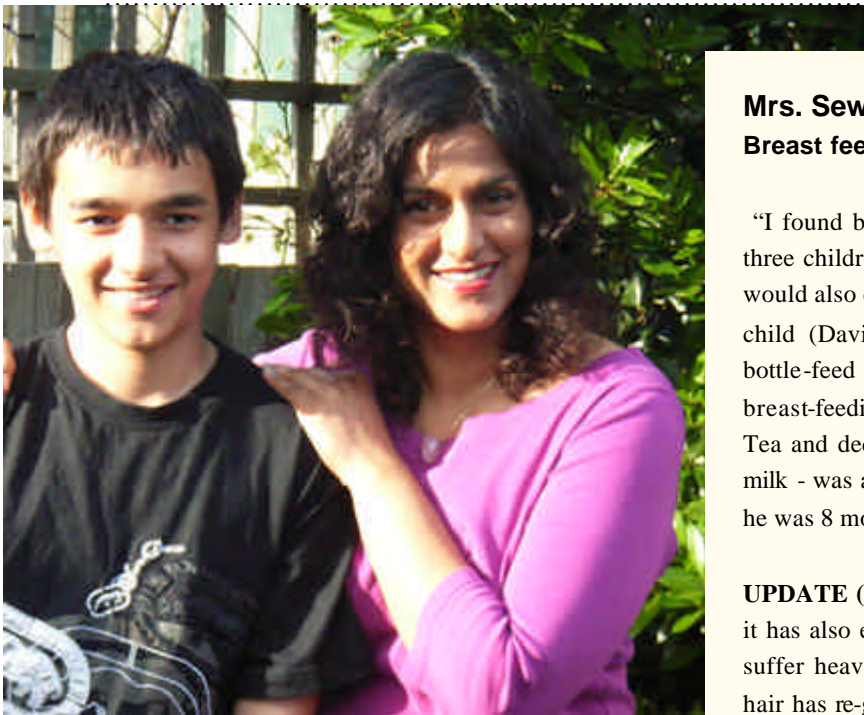

## STRICT CENSORSHIP:

Under the Nutrition & Health Claims Regulation, it is also a ‘**criminal offence**’ to make any ‘**HEALTH CLAIMS**’ on **natural products & foods (i.e. fruits, vegetables, herbs, flowers, etc)**, which directly conflicts with the Government’s health campaign recommending that we eat 5 fruits or vegetables daily to improve and maintain good-health. Furthermore, the legislations does not recognize the original **Divine Laws of Life & Nature (i.e. NATURAL LAW)**, based on the ancient principle that **Natural Foods were provided to both feed & heal**. permanently, such as joint health products, probiotics and antioxidants. This leaves manufacturers and brand owners in an untenable position, unable to satisfy consumer's growing expectations for product information – which will remain available on the internet from unregulated non-EU jurisdictions – while at the same time facing major costs of compliance. Brand names making implied health claims which weren't trade-marked prior to January 2005, will have to be withdrawn and expensive product reformulation and repackaging will be required. To make matters worse, some UK regulatory authorities are already enforcing EFSA 'Opinions' two years ahead of time, and the media is pushing the 'reject claims' story, creating an impression amongst consumers of an industry based on false claims. Reputable businesses will lose sales to unregulated off-shore competitors, and consumer protection will be compromised. Inevitably, sales will fall, and over time products will be withdrawn and product innovation will decline. Both SMEs (*small & medium size enterprises*), unable to fund the cost of compliance, and consumers will be the losers".

The situation is truly illogical because every which way you turn, the Legislations and the Cancer Act threatens the potential and survival of small health businesses, consumer health, rights, choice; plus suppresses the truth.



## RESEARCH FIASCO:

Throughout my 14 years in-house research, I continued to seek 'scientific clinical trials' and was eventually advised by the Department-of-Health that my local Primary Care Trust (PCT) was their front-line section for such services. After several meetings with the PCT Chief Executive, it turned out that they had never conducted such research trials; neither had the expertise; financial resources or man-power to assist me in any way. By 2008, my persistence led to me becoming a nuisance and after nagging for several months, I was finally sent an enormous document titled '**The Research Governance Framework for Health and Social Care 2005**' (from the Department of Health) pertaining to clinical research. I was then advised as follows;-

*'The PCT does not help anyone with potentially beneficial products to establish clinical trials or to raise funding. You have to do it all yourself and once approved, they could then help in organizing the hospitals or doctors to carry out and monitor the research. Even though the process is long and complicated, they do not have the*

*necessary internal support. I would need to find a scientific researcher or professor from an academic unit or teaching hospital, as well as a laboratory.'*

Returning this information to the Public Health Minister, I was then sent another huge document titled **'Transforming Health Research'** - (from the National Institute for Health Research (NIHR) - progress report 2006-2008)... with a foreword by the **Prime Minister (Gordon Brown)** stating –

*"The science base in the UK is the foundation of our economic future and medical research is key to ensure our NHS is well placed to benefit from the latest technologies. One of the founding principles of the NHS was the requirement to conduct research for the improvement of health and medical treatment. The future and health of our country depend on it. Health research has a central role in all of this. It is an undisputed area of strength for Britain, in which I believe we can take great pride. That strength derives from the quality of the research base across sectors: academia, NHS and industry. It is underpinned by the massive and growing investment in health research and development by my Government – **we have committed an unprecedented £17 billion to the Single Health Research Fund over the next 10 years – together with investments from our partners in industry and the research charities.** The work of the NIHR – as demonstrated in this report – will play a key role in ensuring that the **UK remains at the forefront of health research and the location of choice for pharmaceutical research and development**".*

Followed by a foreword from the **Public Health Minister (Dawn Primarolo)** stating - *"This report is published to celebrate the achievements that have been made since we launched 'Best Research for Best Health' in January 2006. Not only does health research enables us to tackle the challenges that disease and ill health present, it also contributes to our international competitiveness and economic growth. Swift progress has been made by **forging new partnerships with both academia and industry, sharpening the focus for 'clinical trials' and reducing bureaucracy, all supported by an increase in funding.** Joining in 'clinical trials' for new technologies and treatments should be available to every patient and clinician, not just those who happen to live near a specialist centre. We have committed an unprecedented amount of money to develop new NIHR research networks and NIHR research centres and units all over the country; and to fund more research itself. Our intention is to make the NHS a hive of research activity that attracts the best researchers in the world. We are **fostering a culture that pioneers new treatments** in the full range of settings, and working to improve health outcomes for all NHS patients. Research is the lifeblood of high-quality healthcare. **Without research, we will have no better understanding of the diseases that blight the lives of so many people, nor any better means of preventing, treating and curing these diseases. Research not only provides us with hope – it provides us with the weapons to fight, and win, the battle against disease.** The funding that the Government recently announced in the Comprehensive Spending Review will enable our NIHR to ensure that new discoveries from basic science are developed and translated into real benefits for patients in the NHS."*

**Note: The main investment partners are the Pharmaceutical Industry & Cancer Research UK, based entirely on researching ‘pharmaceutical drugs’;- plus their target audience included Primary Care Trusts (PCT) throughout the country.**

**One of the NIHR 5 main goals was to  
*‘commission research focussed on improving health and care’***

After sending an official letter of complaint to the Prime Minister (including my research evidence of the UK’s involvement with the African Bush Willow), I immediately received approval from the Public Health Minister but was still left to establish the ‘clinical trials’ on my own. The procedures were so daunting that it almost left me and a professor from Brunel University traumatized.

All-in-all, this report meant that the research funding, expertise and support networks were available, but as a lay-person (with an extraordinary range of innovative British products), neither the Government, Department of Health or local Primary Care Trust offered a willing hand to help me. Instead, I was sent on a deliberate wild-goose chase (for 14 years), simply to keep Zara’s Herbal Tea off the market, with the final assault by the MHRA for surety.

To-date, the Primary Care Trust or Department of Health has neither followed up and or assisted my case for research. Yet, in 2007, my residential area (London Borough of Newham) was reported by the Director of Public Health, to be the eleventh most deprived borough in the country – with the worse female life expectancy in London; highest infant mortality and highest death rates from heart disease (killing over 500 residents each year)... with plans to improve healthcare by 2020. It is one of the 5 London boroughs (with similarly poor health reports) that will be hosting the 2012 Olympic games. Additionally, the area also has one of the highest un-employment records in London and although the Government pledged that these games would bring enormous benefits to UK industry and substantially improve the economy, reports in 2010 confirmed that UK manufacturers were awarded only 8%, whilst the Government gave away 67% to China (to manufacture the games merchandise). Our new Prime Minister (David Cameron) was then seen touting for business in China at the G20 gatherings in November 2010.

## THE CANCER ACT 1939:

This old ACT is another clear example of how the MHRA and other UK Regulators are further abusing their powers. The ACT prevents the public from being informed about any **‘natural food, herb, supplement, remedy or holistic practice’** which is beneficial for **cancer**. Even if proven safe & effective; used successfully for centuries or if scientific evidence exists... it is a **‘criminal offence’** to produce; promote, sell or give away freely to cancer sufferers, if it does not have a **Medical Licence**. However, sufferers are permitted to use (*safe, effective, unlicensed*) **natural products or practices** as a last resort, after all medical intervention has failed and the person is left to die. Incidentally, the majority of people (including doctors, pharmacists, health practitioners) are not aware of the existence of this discriminatory ACT. However, (as in my case) the ACT is used effectively by UK Regulators to force their ‘authority & licensing power’ to further control the commercial markets in favour of the pharmaceutical industry. I was told categorically by the MHRA that although Zara was healed with the herbal-tea, apart from not selling, give away free of charge, promote or advertise this fact, neither must I speak about it; tell the true story; suggest or even hint (in any way) that it could benefit cancer or any other condition.

Another example ... in July 2010, scientific research reported that Broccoli, Brussel Sprouts & Watercress can stop the spread of cancer. These ancient wisdoms, known to many for millions of years are only now being discovered by scientists. However, any lay-person caught spreading this information could be criminalized by the MHRA because Broccoli, Brussels & Watercress are **‘unlicensed’** natural foods. Yet scientists can reveal this information without any threat of prosecution. There are hundreds, if not thousands, of ‘natural foods & products’ known and scientifically proven to be beneficial for cancer - including hot-peppers, turmeric, apricot kernels (B17), red clover, burdock, dandelion root, slippery elm - plus the most recent scandal to be uncovered is the South American/Caribbean Sour-Sop Plant (also known as Graviola). American scientists deliberately buried 40 years research on this plant because they have failed to create a synthetic-drug derivative; claiming it to be the most powerful anti-cancer plant - 10,000 times more powerful than chemotherapy. Cancer-sufferers were never informed of this groundbreaking discovery, yet this is a common fruit which I and all South Americans & Caribbeans were brought up on. Additionally, in 1987, I was the first to report that ‘hot peppers’ were cancer preventatives, which scientists finally confirmed 20 years later. There is a wide ranging bibliography of writing about how ‘natural treatments’ have been hampered and blocked and how ‘natural products’ have been taken off the market... and many more from non-European countries could be banned from 2011.

## CANCER ACT – REFORM APPLICATION (2010):

I have attached a 30 page application submitted to the Law Commission on 15<sup>th</sup> October 2010 for the reform of the Cancer Act 1939. *\*For clarity, certain parts of the document have been duplicated in this case study.* It proves the Act to be out-of-date, bias, discriminatory, unjust and no longer meet the needs of the people. It also provides clear evidence that the Act was established solely for scientific purposes to support experimental cancer drug treatments and not for research into cancer prevention using ‘alternative methods’. Therefore, for 71 years, the entire nation has been deliberately deceived into believing that the Pharmaceutical Industry, Scientists, Medical Establishment and the Government are actually researching cures for cancer when in fact they are simply experimenting. Many people die from the side-effects of drugs such as chemotherapy, radiotherapy, morphine and other toxic poisoning, instead of the cancer itself or many are left permanently damaged. Billions are being raised for **experimental research of ‘pharmaceutical drugs’**, yet still **‘no cures’** are in sight... to the detriment of millions whose lives could have been improved or saved, if *‘alternative methods’* were given a fair chance.

71 years ago cancer was a considerably rare condition affecting only 1 in 40 to 50 people... however current statistics shows cancer has now reached pandemic levels of 1 in 2 or 3. This result proves that cancer-drugs have been hugely ineffective and is the most appalling medical failure to date.

71 years ago, the UK population comprised mainly of Caucasian born UK citizens. In comparison, 71 years on, the demography has completely changed, as today’s UK population consists of a large and growing number of foreign UK citizens - 1 in 10 (i.e. Chinese, Indian, Caribbean, African, European and others), whose cultural traditions recognizes the effective use of more natural therapies. Government but by the Pharmaceutical Industry. It appears to signal absolute Pharmaceutical control ensuring that only 'prescription medication & over the counter drugs' are available for patient-care throughout the country. This will firmly bolt the doors to 'alternative natural treatments' within hospitals, doctors, chemists and pharmacies. It also adds further weight to the new EU Legislations (*The Nutrition & Health Claims Regulation*) to be adopted as UK Law from 2011, which will outlaw all '**Health Claims**' on natural foods, plus the (*European Food Supplements Directive*) banning thousands of natural products (i.e. foods, herbs, vitamins, minerals & supplements) from the UK and European markets.

And there is still one even more worrying factor involved here, that is - that GP's and general doctors will become increasingly involved in using their patients for research in the testing of unproven cancer drugs.

Such a 'pact' between the pharmaceutical industry, regulators, politicians and doctors, opens further ethical questions of... accountability; conflict of interest; abuse of power; control of commercial competition; suppression of adverse side-effects; human experimentation 'without informed consent' and consumer-choice.

## CODEX ALIMENTARIUS (Standards and Guidelines):

### BAD SCIENCE, BAD LAW

Codex Alimentarius is Latin for “Food Code” and is the name taken by an international body created by the Food and Agriculture Organization and the World Health Organization in the early 1960s. With two stated missions (‘to eliminate international barriers to trade’ and ‘to protect the consumer’), the Codex Alimentarius Commission has been developing food standards and guidelines for almost 50 years now. And countries send their food bureaucrats as delegates to attend these meetings and laboriously create intricate and exacting standards that many of them think are based upon “science.” Industry also sends its own representatives to participate in the creation of these standards and guidelines using this “science.”

The problem is that the ‘science’ that is being used is junk science – either very outdated or deliberately skewed. Yet, the vast majority of the delegates fervently worship the FAO/WHO “expert consultations” that constitute the source of this science. Should anyone dare to challenge the validity of this science – as the **National Health Federation**, the only health-freedom group that may speak out at Codex, has done – then *they* are the ones considered the heretics.

Keep in mind: these are global rules, intended to be put into place both internationally *and* domestically. The Codex Alimentarius Commission’s own *Strategic Plan 2008-2013* says so. The U.S. Food and Drug Administration agrees. And the European Union’s own **Food Supplements Directive (FSD)** was written *explicitly* with these Codex guidelines in mind and with the idea that the EU delegate would also help shape the Codex Guidelines on Vitamin and Mineral Food Supplements to be in the FSD’s own image. The big players at Codex want uniform food rules applied globally.

And for those Codex delegates who do not have this agenda in mind, they get wrapped up in a kind of ‘Group-think’ that lets them be led by those with an agenda. The group-think slogan is “consumer protection”; but

the reality is that Codex is not protecting the consumer so much as it is suppressing individual liberty, the right for each person to decide what foods he or she would like to eat. And with many of the key country delegates having been ‘captured’ by special commercial interests (such as the manufacturers of drugs, GM foods, aspartame, and melamine) who want to suppress their competition through freedom-stifling rules and regulations, it is easy to see how these special interests can manipulate the bureaucrat-delegates – who already have a ‘protective’ mindset – to agree that more restrictions are necessary on safe foods and supplements.

Supplements are already the safest form of foods on the planet, with a death rate somewhat higher than being struck by a meteorite and lower than that of being stung by a bee or falling from a horse. Yet because supplements represent a threat to the ‘sickness’ agenda of so many commercial and bureaucratic interests, they are a regulatory target. Supplements and other healthy foods will be restricted, dumbed-down, and made less available and more expensive.

The time table for all of this has not been set in stone, but is anticipated to take place in the United States within a few years. In Europe, however, because of the EU’s FSD, it has already started to occur in a major way, with many supplements being removed from store shelves since the FSD took full effect as of December 31, 2009. This, however, is very different than Codex taking full effect.

In short, enforced by the World Trade Organization and increasingly written into treaties and national legislation, Codex has become *the* major player on the global food stage. Hijacked by special commercial interest groups working hand-in-glove with their like-minded government counterparts who would like nothing more than to straight-jacket society and the economy, Codex has unfortunately become a force for eliminating natural remedies and health. As always, better health comes from *more*, not less, health freedom.

## **‘HUMAN RIGHTS & CRIMINAL OFFENCES’:**

(experimentations without our knowledge or consent).

The Government has allowed experiments on the nation for far too long and to our detriment. For example, the deadly Bovine Spongiform Encephalopathy (BSE) *also called ‘mad cow’ disease*, was known to the Government for over 20 years but still declared it **‘posed no health risk and therefore safe for human consumption’**, until it was transmitted to humans as Creutzfeldt-Jakob Disease (CJD) from the meat and milk of cows and sheep. BSE and CJD have an incubation period of over 20 years (before detection) and therefore still remains a permanent threat to our health. Death statistics from 1990 to 2010 totals 1,553. Apart from synthetic drug-medication, our food supply has virtually become artificial (with genetically modified foods & ingredients which are also being fed to animals to guarantee human consumption; irradiated foods; pesticides and other toxic poisons)... plus the most recent revelation of **‘cloned milk & meat’** reported to be in the food chain. Although illegal in the UK, a Scottish farmer revealed, **‘if the Government prevented him from selling his cloned meat, he would simply export it to Europe (where it is legal), who would then put it into processed meats and resell it legally back to the UK’**. CLONING is both an abnormal and un-natural process with unknown long term side-effects. It is un-approved, untried & untested experimentation, and although ‘Dolly the Sheep’ (Britain’s first cloned animal) died prematurely, due to rapid aging and other serious side-effects, the Food Standard Agency (FSA) now claims that the produce of ‘cloned animals’ pose no threat to our health.

**On 26<sup>th</sup> November 2010;** the Advisory Committee on Novel Foods and Processes (ACNFP) carried out a hypothetical assessment on whether food from cloned animals could go into supermarkets. It confirmed previous reports from European and American food watchdogs that any meat and milk would be equivalent to that produced from conventionally reared animals. The Food Standards Agency said that the committee noted that evidence showed no difference in composition between the meat and milk of conventional animals, clones or their offspring and is therefore unlikely to present any food safety risk. In which case - **how do they know, who have they tested it on and for how long?** As cloned produce could be sold without a ‘license & un-labeled’ it is in the public interest that all research evidence is revealed. Animal welfare campaigners including the RSPCA and Compassion in World Farming also insist cloning is cruel... claiming that there are high levels of premature miscarriages, organ failure and gigantism amongst clones. With this in mind, it is highly probable we could witness the same repercussions as with the deadly BSE, or even worse.

Another example ... Every year, over 20,000 people in the UK and 500,000 worldwide die from the 'common flu', which is virtually ignored. In 2008, scientists reported that the annual winter 'flu-jab vaccine' was ineffective and a waste of NHS funding. However, last year, we witnessed the sudden outbreak of the '**swine flu**', which within a few months was given pandemic status. And for the first time, the global population was targeted for mass vaccination. It was reported that 'a patent' for the Swine-Flu vaccine was approved for one of Europe's largest pharmaceutical corporation's (Baxter International) a month before the outbreak was first declared in Mexico. Shortly after, mass hysteria was being spread throughout the UK via the Government, NHS and national media. Approval for the **H1N1 vaccine** (untried or tested for effectiveness or safety) was fast tracked, to commence mass vaccinations from October 2009. The Government gave the Pharmaceutical Industry total immunity from prosecution against any vaccine damage. Then set up call centres managed by unqualified and untrained staff to diagnose 'swine-flu' using a symptom-chart. However, differentiation between the symptoms of '*swine flu, normal flu or the common cold*' (all being related) caused confusion amongst scientists, doctors and nurses alike. Furthermore, parents were put on a guilt-trip as being 'irresponsible and abusive' for not vaccinating their children. On the other hand, video '**Vaccination - The Hidden Truth**' (produced in 1988 - [www.joininghandsinhealth.com](http://www.joininghandsinhealth.com)), features doctors and scientists revealing that vaccines contain toxic substances designed to cause ill-health. They contain not only 'live' germs but also toxic chemicals such as squalene, diphtheria, formaldehyde, hydrochloric acid, mercury, aluminum, ammonium, antifreeze, animal DNA and more. They also damage the brain and cause chronic illnesses such as cancer, autism, diabetes, meningitis, allergies, plus alter our DNA and damage the immune system, which is then passed on throughout generations.

This is only the tip of the ice-berg of questionable human experimentation and opens the questions.

and annual vaccinations for over 15 years. The **Veterinary Medicines Directorate (VMD)** is the UK Regulatory Agency, whose role is to protect public health, animal health, the environment and promote animal welfare by assuring the safety, quality and efficacy of veterinary medicines. They are the animal equivalent of the MHRA, responsible for licensing and marketing authorization of veterinary medicines, allied with the pharmaceutical industry.

My research led to countless evidence confirming collaboration and corrupt insider dealings between the MHRA, Pharmaceutical Industry & the Government. Here are a few:

*laboratory is unbelievable. They control everything (the NHS, Government and the law)".* He made me promise to never reveal his name).

- (2001). Two British ‘Noble Prize’ cancer research scientists Sir Paul Nurse & Tim Hunt revealed that... “there is no single cure for cancer and many more years of research was still required.” And Gordon McVie the then head of Cancer Research UK stated in the Observer magazine that... “many promising new drugs have arrived on a wave of hype in the past 30 years and almost all have disappointed. Often it has been ‘natural products derived from plants and fungi’ that have proved most effective.”
- (2003). Dr. Allen Roses Vice President of GlaxoSmithKline – one of the world’s largest drugs companies, confirmed before a parliamentary committee hearing that, “90% of modern drugs only work in about 30% of patients”. According to Mr. Craig Sams ex-chairman of the British Soil Association – “Every year the National Health Service spends £7.2 billion on drugs. Investigative writer Martin J Walker author of **The Fate of a Good Man** reveals;- “Despite being a department of the British Government, the MHRA is funded entirely by pharmaceutical companies and a percentage of staff and executives come from the pharmaceutical industry. The MHRA is also the largest pharmaceutically-funded enforcement and policing agency in Europe; plus linked to the BBC, which frequently carries quack-busting magazine items on its behalf. United States. Sometimes drugs companies hide or downplay information about serious side effects of new drugs and overstate the drugs benefits. They then spend two or three times more on marketing than on research to persuade doctors to prescribe these new drugs. Doctors may get misleading information and then misinform patients about the risks of a new drug. Because they are in charge of drugs testing, they build ‘*fire walls of legal protection*’ around information on the harmfulness or effectiveness of new drugs and the Regulators set the bar low for drug efficacy in the first place. Furthermore, drug companies ‘swamp the Regulator’ with large numbers of incomplete and poorly designed trial data. The result is that drugs get approved without anyone being able to know how effective they really are or how much serious harm they will cause.”



## CHRONIC DECLINE IN THE NATION'S HEALTH:

50 years ago, sickness was considerably rare - due mainly to the consumption of a ‘nutritionally balanced diet of natural foods, supplements & herbal remedies’... but since scientific *interference and manipulation*, sickness has now reached pandemic proportions across the globe. - **Obesity** – (1 in 4 adults; 1 in 10 children)
- **Allergies** - highest rate in Europe
- **Asthma** - highest rate in the world (1 in 13 adults; 1 in 8 children)

Coupled with HIV/Aids, arthritis, thrombosis, kidney disease, alzheimers, dementia, etc – the list grows longer every year and there seems to be no real solutions or cures in sight. Therefore, the likelihood of one member in every family falling prey to a terminal condition is extremely high.

## PERSONAL ACTION:

Based on the above evidence and lack of support from the establishment, I called on the Government to **OPT OUT** of the EU Legislations and forthcoming Codex Alimentarius. And in its place, establish an independent legal framework based on **NATURAL LAW & COMMON LAW**. In July 2009, I sent an 'open letter' to:-

- The then Prime Minister (Gordon Brown);
- Opposition Leaders (David Cameron, Nick Clegg, Nigel Farage, Caroline Lucas)
- All members of the House of Commons,
- All members of the House of Lords,
- All members of the Regional Assemblies (Greater London, Scotland, Northern Ireland and Wales)
- and all UK members of the European Parliament.

With the exception of Baroness Howells of St. David's (Parliamentary spokesperson), UKIP MEPs, a few MPs and Lords, no one else responded. However, to my delight, this led to a personal invitation by Mr. Godfrey Bloom (UKIP MEP) to present my case directly to all 700 EU-MEPs in the European Parliament (in Brussels). This took place on the historic remembrance '**Armistice Day**' (11<sup>th</sup> November 2009)... a poignant reminder of the millions of UK & Commonwealth soldiers who so gallantly fought and died to preserve our Sovereignty, Democracy & Freedom. And although each year Your Majesty, the Prime Minister, Parliamentary Members and Church leaders, stand alongside the nation to pay public tribute, by solemnly promising to '*always remember and never forget their sacrifice*'... our presence in the European Union suggests that they died in vain. I was also horrified to be told by MEPs that the **EU is a non-democratic 'corporate' organisation**, focussed on control, power & wealth. In addition, I also submitted an **OPT OUT Agreement** to all 72 UK MEPs, but when it came to putting 'pen to paper', the overwhelming majority showed a distinct lack of courage – (only 3 UKIP and one Conservative MEP signed). The others were too afraid to sign the Agreement because they said that Your Majesty and the Government had secretly given away our sovereignty to the EU, without the consent of UK citizens... and that this contravenes **the British Constitution 'Bill of Rights' (1689)**. **If this is true, then our entry in the EU is illegal**.
