OPEN LETTER 29 November 2012

F.A.O: The Prime Minister; Deputy Prime Minister.

WARNING

'Pensioners deaths set to rise this winter'.

- 2010/11 = 24,430 pensioners died.
- 2012/13 = forecast to be the coldest, plus increasing household fuel & food bills, could set a new record this winter.

There are approximately 10 million pensioners (over the age of 65) in the UK and each year over 20,000 die during the winter months - December to March. According to AGE UK, there were 24,430 excess deaths in 2010/11. For the past 5 years, the number dying from hypothermia, circulatory, respiratory & heart conditions has doubled, but this year's winter forecast to be 'the coldest', plus increasing 'household fuel & food bills' could set a new record, as poverty stricken pensioners will be forced to continue to choose between eating and heating their homes. Moreover, respiratory and circulation problems are made worse in cold, damp conditions; which without food to provide the body with essential fuel, heat and energy to keep warm, will simply add to the death toll. And although the Government provides 'cold weather payments', it is not sufficient to prevent, reduce or bring an end to this devastating problem.

To make matters worse, in November 2012 - the **Chief Medical Officer** warned that "patients should not request **antibiotics** for coughs and colds due to increasing resistance to treatments. Common infections may become impossible to cure, if antibiotics are not used responsibly. Drug resistance is one of the biggest threats to modern health."

The Centre for Infectious Disease Research and Policy, also warned that the 'Flu Jab vaccine' promotions have been over-hyped and over-exaggerated, with no decent studies conducted to prove its effectiveness for the over 65s. One expert suggested, the Government should be held to account for wasting tax-payers money on the annual £120 million national campaign waged to encourage public uptake of the vaccination. Plus, a survey by the General

Medical Council discovered that **doctors misdiagnose 10% of chronic ailments** such as heart problems, arthritis and cancer, which means people could be taking powerful drugs (with serious side effects) for no good reason. More than 40% of the elderly given a prescription have an error in it – and sometimes the mistake is fatal. The over 75s are at the greatest risk because they are given the most prescriptions.

- **Dr. Donald Light's** research findings in 2010 revealed that **85% of new drugs offered** few, if any benefits at all.
- Statistics confirm that 'prescription medications' are not only extremely toxic and addictive but also the NO1 cause of deaths in America and NO3 in the UK.
- Coupled with the recent rise in 'hospital deaths', due to over-crowding, poor hygiene and bacterial infections.

Collectively, this puts the 'health & life' of the elderly at even greater risk.

In 2012, it is an absolute disgrace that UK 'senior' citizens are dying for lack of heat, food-and effective medical-care.
